3. **PAPER COPY.** I agree that I can obtain a Paper Copy by printing the Form from the website.
4. **CANCELLING AUTHORIZATION.** I understand that I can come back to this page at any time to Cancel this Authorization.
5. **EXPIRATION DATE.** I agree that any 1099 Forms that are available through this website will be available for at least 1 full calendar year from the time the Forms are made available to me. The forms will be retrievable through the website even if I no longer have a login to the system.
